### Eligibility Criteria and Conditions

- 1) Combined Household Income of all residents \_\_\_\_\_ Proof of income required.(Tax Return)
- 2) No able bodied person under the age of 65 can reside at the home.
- 3) The Emergency Snow Removal Program will only be activated after 3 inches of Snow has fallen.
- 4) The Work Crews will only be dispatched after the snow has ended and roadways are clear.
- 5) Snow will be removed to provide Emergency Access into/out of the home. A path will be cleared from the home to the street for residents and /or Emergency Personnel such as Police / Fire / EMT
- 6) Built up Ice will not be removed from any surface. Chemical Ice Melt will be spread by Work Crews only if provided by the Home Owner
- 7) Works Crews clear Emergency Vehicles and County Properties prior to being dispatched to Private homes. A delay of up to 48 hours can result based on the timing of storm and the amount of snow.
- 8) Home Owners must have an Emergency Back-Up Plan. It could take up to 72 Hours before a Work Crew shows up to clear a path.
- 9) Notifications of approval or denial will be made via telephone

# URGENT

## Correction from the 2017 Senior Pathway regarding article on Senior Snow Removal

This program was designed for seniors with limited financial resources.

The Passaic County Sheriff's Department will provide an emergency access path from the door to the street. The path provides access for Police / Fire / EMT's and for the home owner to have an escape route in case of an emergency.

**\*\*\*We do not shovel Driveways / Parking Spaces / Sidewalks\*\*\***

### **Eligibilities:**

- Only Single Family Homes - No Renters or Tenants.
- No one under the age of 65 can reside in the Household.
- Combined household income of less than \$24,000 per Year (Social Services Guidelines)
- Proof of Income is required (Tax Return).
- Crews will only be activated after 3 inches of accumulated Snow has fallen.
- Crews will not be activated until the snow has ended and the roadways are clear.
- Work crews clear County Emergency Vehicles and County Properties prior to being dispatched to private homes, as such a delay of up to 48 hours may result based on the timing of the storm and the amount of snow.
- Home owners must have an emergency back-up plan in place. It may take up to 72 hours before a work crew shows up to clear a path.
