- Whether the applicant has received any other filming permits in the City of Clifton in the 12 month period immediately preceding the application and, if so, the exact filming location of each such permit and the number of days that filming for each such permit took place.
- Any other pertinent information that may impact the safety, health and/or public welfare.

CITY OF CLIFTON, NJ

Permit applies to regulations under Chapter 317 of the City Code and in general refers to still or motion pictures either filmed or videotaped, etc., on public lands for viewing on television, in theaters or for institutional use.

The hiring of an off-duty Clifton Police Officer at rates set by the Clifton Police Department for the times indicated on the permit. The Chief of Police shall determine, in his discretion, the number of officers required to maintain the public safety.

The undersigned further agrees to and shall indemnify and save harmless the City of Clifton, its officers, agents, servants and/or employees against any and all liability, claims, judgments, demands or expenses whatsoever in connection with the loss of life, personal injury and/or damages to property arising out of the aforesaid activity. The insurance coverages hereinabove stated for the benefit of the City of Clifton shall include contractual insurance covering the indemnification and save harmless provisions of this agreement.
